### Representative Matters

#### Commercial Litigation

Representing the owner of a hospital under construction in Lake Travis, along with Abe Kuczaj and Steve Wingard, prevailed after a two-week long jury trial in a breach-of-contract case. In its verdict, the jury found defendants breached their confidentiality agreement and caused damages to SDM's client. The court also awarded attorneys' fees to SDM's client.

After winning a final judgment against defendants Lakeway Regional Medical Center and Surgical Development Partners, along with Abe Kuczaj and Steve Wingard, filed an application for an injunction to preclude one of the defendants from dissipating or transferring assets to avoid

satisfaction of the judgment pending appeal of the final judgment. Finding that SDM presented evidence establishing that the defendant was likely to dissipate or transfer assets in the future to avoid satisfaction of the judgment, the Court entered an injunction in favor of SDM's client.

Along with Ryan Squires, represented a jewelry store in claims against an alarm-monitoring company following a burglary of the jewelry store. Jury verdict in favor of SDM's client.

Successfully defended a large national hotel chain in premises liability and dram shop cases.

Successfully defended a large national retail chain against claims for discovery sanctions made in premises liability cases filed all over the country.

Defeated a temporary injunction sought by a plaintiff that would have prevented a national non-profit organization from raising necessary funds, and later obtained a dismissal of the lawsuit.

Represented an Austin-based insurance agency in claims against a multi-national insurance company and its third-party administrator for fraud and unfair insurance practices arising out of the sale and administration of extended automobile warranty contracts.

### Governmental Entity Representation

Along with Casey Dobson, represented Austin's municipally-owned utility, Austin Energy, in a complex contractual dispute over electric transmission congestion in association with a West Texas wind farm. Jury verdict in favor of Austin Energy upheld on appeal.

Obtained a voluntary, non-settlement-related dismissal of all claims based on a developer's allegations that the City of Austin breached a prior settlement agreement and made a taking of the property at issue.

### Professional Malpractice Defense

Representing one of the largest law firms in San Antonio, along with Casey Dobson, prevailed after more than a week-long jury trial in a breach-of-fiduciary-duty case. Plaintiff, a former client of the San Antonio firm, sued alleging legal malpractice and breach of fiduciary duty and sought damages in excess of \$40 million. After defeating plaintiff's legal malpractice claims and establishing the client had suffered no damages, as a matter of law, the jury trial proceeded solely on the issue of whether defendants breached their fiduciary duties. In its verdict, the jury unanimously found in favor of SDM's client. The court then entered a final judgment that the plaintiff take nothing and imposed costs on the plaintiff. Plaintiff did not appeal the judgment.

Defended attorneys and law firms in legal malpractice and breach of fiduciary duty cases arising out of various areas of underlying substantive law, including commercial litigation and probate work.

Represented physicians in disciplinary actions brought by the Texas State Board of Medical Examiners.

### Technology Litigation



Along with attorneys from Kilpatrick Townsend, successfully defended Motorola Mobility in a jury trial against patent infringement claims related to wireless earpiece technology in the Western District of Texas. The jury returned a verdict of non-infringement and invalidity against all claims that were at issue.

Along with Steve McConnico, Steve Wingard, and lead counsel from Latham & Watkins, won dismissal of a patent infringement lawsuit when our Motion to Disqualify opposing counsel was granted. SDM represented a large, publicly-traded energy company in defense of claims brought by a publicly-traded non-practicing entity. SDM filed a motion to disqualify plaintiff's in-house general counsel, plaintiff's entire legal department, and plaintiff's outside counsel. In addition, SDM requested that the court dismiss the lawsuit. The court granted SDM's motion, disqualified all of plaintiff's counsel, and dismissed the lawsuit.

Assisted as local counsel in technology litigation involving claims of trademark, copyright, and patent infringement, and misappropriation of trade secrets.
