breach-of-contract case. In its verdict, the jury found defendants breached their confidentiality agreement and caused damages to SDM's client. The court also awarded attorneys' fees to SDM's client.

After winning a final judgment against defendants Lakeway Regional Medical Center and Surgical Development Partners, along with Abe Kuczaj and Paige Amstutz, filed an application for an injunction to preclude one of the defendants from dissipating or transferring assets to avoid satisfaction of the judgment pending appeal of the final judgment. Finding that SDM presented evidence establishing that the defendant was likely to dissipate or transfer assets in the future to avoid satisfaction of the judgment, the Court entered an injunction in favor of SDM's client.

Won a Motion to Dismiss for Lack of Standing and Plea to the Jurisdiction in favor of the general partner and limited partners of a family limited partnership. SDM defended a limited partnership, its general partner, and several individuals who owned limited partnership interest in lawsuit asserting breach of fiduciary duty. The plaintiff was the executor of the estate of a deceased limited partner who claimed the right to bring derivative claims on behalf of the limited partnership. The Court dismissed the lawsuit holding that the plaintiff lacked standing to bring his claims.

Along with Jane Webre and Robyn Hargrove, prevailed in an appeal of summary judgment orders. SDM represented the operator of a well in Reeves County, Texas. After the well suffered a blowout, the insured paid to bring the well under control, to attempt to restore production at the well, and to address pollution cleanup. The insured filed claims with its insurance carriers under well-control and commercial-general-liability policies, but the carriers denied coverage. SDM won summary judgments at the Midland County District Court, which ruled that the well was a "well-insured" under the policies and that the insured incurred damages in excess of the policies' limits. The insurance companies appealed to the Eastland Court of Appeals. Finding no error, the Eastland Court of Appeals

affirmed the trial court's summary judgment rulings and taxed all costs against the insurance companies.

Represented 43 employees of a Texas start-up purchased by a large European consortium in several lawsuits claiming wrongful cancellation of option agreements and breach of an employee retention agreement. Tried case and obtained favorable jury verdict on behalf of three employees in one venue. Thereafter, obtained successful settlement on behalf of remaining clients.

Along with Steve McConnico, Paige Amstutz, and lead counsel from Latham & Watkins, won dismissal of a patent infringement lawsuit when their Motion to Disqualify opposing counsel was granted. SDM represented a large, publicly-traded energy company in defense of claims brought by a publicly-traded non-practicing entity. SDM filed a motion to disqualify plaintiff's in-house general counsel, plaintiff's entire legal department, and plaintiff's outside counsel. In addition, SDM requested that the court dismiss the lawsuit. The court granted SDM's motion, disqualified all of plaintiff's counsel, and dismissed the lawsuit.

Represented lawyer and law firm in legal malpractice case arising out of patent prosecution of five related patents and six separate patent infringement lawsuits. Secured favorable settlement prior to trial.

Represented large professional employment organization in appeal of state tax decision imposing liability for unemployment compensation taxes. Secured favorable ruling from hearing examiner for the Texas Employment Commission.

Represented lawyer in disciplinary proceeding arising out of complaint alleging professional misconduct. Secured dismissal of complaint from Summary Disposition Panel for the Grievance Committee.

Represented start-up company in multi-million dollar lawsuit brought by large European corporation alleging breach of

contract and theft of trade secrets related to internet protocol router technology. Case settled after company successfully defeated application for temporary injunction.

Represented family-owned company in breach of contract lawsuit arising out of the sale of its assets to a competitor. Secured summary judgment on behalf of clients, which was affirmed on appeal.

Represented drug manufacturing corporation in lawsuit brought by the State of Texas alleging violations of the Texas Medicaid Fraud Prevention Act. Secured favorable settlement on behalf of client.

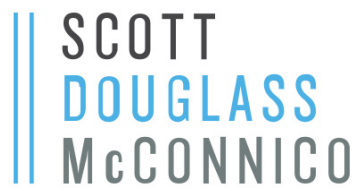
